HIGH EFFICIENCY CLOTHES WASHER REBATE PROGRAM

The City of Greenfield offers a High Efficiency Clothes Washer Rebate program to provide financial assistance to customers wishing to purchase high efficiency, water conserving clothes washers for their home. The rebate amount is \$150 or the cost of the clothes washer, whichever is less. This rebate program is for single and multi-family residential customers and properties only. Maximum of one rebate per residential property. The amount of rebate may not exceed the customer's actual cost. Installation of the clothes washer is the sole responsibility of the applicant. This rebate program is available on a first-come-first-serve basis subject to funding availability.

Rebate Eligibility Requirements

- The clothes washer must be installed at a location served by the City of Greenfield.
- The clothes washer must be both ENERGY STAR® and HE labeled meeting energy and water consumption standards established by the Consortium for Energy Efficiency. Verify with the appliance retailer that the clothes washer you are purchasing qualifies as an ENERGY STAR® and HE labeled appliance. To learn how various ENERGY STAR® qualified washers are rated in terms of energy and water savings, go to www.energystar.gov.
- The clothes washer must be purchased new at retail price on or after June 1, 2015. Resale or lease/rental option clothes washers are not eligible.
- The rebate does not apply to hoses, fittings, or installation charges.
- An on-site inspection by a City representative, or other proof of installation, may be required to verify installation.
- Proof of purchase and installation is required. Attach to the completed application form the original sales receipt showing the clothes washer model and date of purchase.
