**ADOPTION OF A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GREENFIELD APPROVING THE MEMORANDUM OF UNDERSTANDING DATED JULY 1, 2013, BETWEEN THE CITY OF GREENFIELD AND THE SERVICE EMPLOYEES INTERNATIONAL UNION (SIEU) LOCAL 521, CTW/CLC FOR THE PERIOD OF JULY 1, 2013 – JUNE 30, 2015
RESOLUTION #2013-64**

Staff report was given by City Manager Stanton. She reviewed the changes to the MOU.
