BACKGROUND:

The League's 2023 Annual Conference is scheduled for September 20-22, 2023 in Sacramento. An important part of the Annual Conference is the Annual Business Meeting on Friday, September 22, 2023 at the SAFE Credit Union Convention Center. At this meeting, the League membership considers and takes action on resolutions that establish League policy.
