<p>In addition to the "Encroachment Permit General Provisions", all permittees must comply with the following requirements:</p> <ol style="list-style-type: none"> 1) Permittee shall call USA at 811 (or 1-800-642-2444) at least 48 hours before digging; 2) Permittee shall repair disturbed streets, curbs and gutters, and ramps in accordance with City of Greenfield Standards; 3) Permittee shall request an inspection at (831) 674-2635 prior to, during all phases of construction and upon completion of the project; 4) Permittee shall always maintain a copy of the approved Traffic Control Plan (TCP) on site; 5) Permittee shall notify the following Emergency Services prior to street closure: <ol style="list-style-type: none"> a) Public Works Department at 831.674.2635 b) Fire Department at 831.674.5484 c) Police Department at 831.674.5111 6) For street/pedestrian closures, permittee shall maintain one-way traffic unless detour signs are installed 72 hours in advance. <p>The undersigned applicant/permittee agrees that the work will be done in accordance with all City Standards and Specifications and is subject to this permit's terms and conditions, the State Vehicle Code, the State Streets and Highways Code and is subject to inspection.
